RECORDING INFORMATION FOR THE STATE OF VIRGINIA



Every effort has been made to ensure that all information is correct and current. If you find information that is not correct, please let us know.

HOW TO CALCULATE TRANSFER TAXES IN VIRGINIA:

For the Deed:

- **State Transfer Tax** – Round Sales Price up to the nearest \$1,000.00. Divide this number by 1000 and multiply the result by 2.5.
- **County Transfer Tax** – Round Sales Price up to the nearest \$1,000.00. Divide this number by 1000 and multiply the result by 2.5. Divide this number by 3.
- **Grantor's Tax** – Divide Sales Price by 1000 and multiply this figure by \$1.00.

For the Mortgage:

- **State Transfer Tax** – Round Loan Amount up to the nearest \$1,000.00. Divide this number by 1000 and multiply the result by 2.5.
- **County Transfer Tax** – Round Loan Amount up to the nearest \$1,000.00. Divide this number by 1000 and multiply the result by 2.5. Divide this number by 3.
- **Grantor's Tax** – Does not apply to the calculations on the Mortgage.
